## Request to be Placed on Boat Slip Waiting List

I am requesting to be placed on the 'Summit Village Association Boat Slip Waiting List'. I am currently the owner of a home or condo in Summit Village, which can be verified through records at the Antrim County Registrar of Deeds, or Office of Equalization. I understand that I must remain a Summit Village home or condo owner in good standing to remain on the waiting list.

I acknowledge that:

1. A \$200 registration fee is required at the time I make this request to place my name on the waiting list.
2. The \$200 fee will be applied toward my first year's dockage fee when I acquire a slip.
3. This fee is refundable upon demand by simply notifying the Beach Club Chairperson in writing that I no longer wish to remain on the list, or that I'm no longer a Summit Village home or condo owner.
4. If I turn down a boat slip when one becomes available, I may forfeit my \$200 fee.
5. Should the time come that I no longer own a home or condo in Summit Village, I accept that it is my responsibility to notify the Beach Club Chairperson in writing within 90 days to remove my name from the waiting list. Failure to do so will result in loss of my \$200 registration fee.
6. It is my responsibility to keep my contact info up to date by notifying the Beach Club Chairperson in writing of any changes to the information listed below. I accept that I forfeit my \$200 registration fee if the Beach Club Chairperson is unable to contact me as a result of my failure to update this information.
