

Beach Club Rules & Regulations

Summer Season Hours: 9:30 A.M. - 9 P.M.

All guests of the Summit Village Association Beach Club are expected to observe and follow the Beach Club rules and regulations listed below while visiting the Beach Club. Failure to do so will result in loss of Beach Club privileges. The rules are designed to provide a safe & pleasant environment for everyone. Beach Club attendants have been asked to report any offenders to the Beach Club Chairperson.

WHO MAY ENJOY THE USE OF THE BEACH CLUB:

1. All Summit Village home, condo, or lot owners in good standing, and members of their immediate family.
2. Houseguests, and rental guests, of Summit Village home and condo owners in good standing.
3. Fisherman's Paradise lakefront property owners with an ID card, and their guests.
4. VPN Timeshare Owners staying in Summit Village may visit the Beach Club providing they have a pass confirming the dates of their stay in Summit Village. These guests, however, may **not** reserve the Clubhouse or Pavilion.

The Beach Club is NOT for the use of Schuss Village or Cedar River Village property owners or resort guests.

RULES TO BE OBSERVED WHILE USING THE BEACH CLUB:

1. The Beach Club is a **NON-SMOKING ENVIRONMENT**.
2. **NO PETS** are permitted on the premises.
3. You must show your ID card, or pass, and sign in at the Beach Club entrance each time you visit. Guests must be accompanied by the property owner.
4. Respect the Beach Club attendants. They are there to help. If advised of rules or regulations, please follow their suggestion.
5. Swim at your own risk. **NO LIFEGUARD IS ON DUTY**.
6. No swimming in the boating area. No boating in the swimming area.
7. No water skiing from the dock or raft.
8. **Motorized personal watercraft are not allowed anywhere in the Beach Club area.** This includes swimming, shore station, or boat mooring areas.
9. Excessive noise is not allowed. This includes radios, boom boxes, CD players, etc.
10. Cooking is restricted to grills only.
11. Park in the designated parking lot. The vacant lot behind the parking lot is for overflow parking only.
12. You are responsible for your own possessions and for cleaning up your area.
13. **Summit Village Association assumes no responsibility for loss or damage to boats or personal property.**

RENTAL BUOYS:

1. Home, condo, or lot owners may rent day buoys for their own personal use. Only one day buoy may be rented per owner at any one time. Multiple owners of a single property will be treated as one owner. **Property owners that are assigned a boat slip may not rent day buoys.** _
2. Timeshare Owners will be given the opportunity to rent day buoys that remain unreserved 14 days prior to a desired rental period. All requests must be submitted in writing and must be accompanied by evidence of timeshare ownership in Summit Village. The Beach Club Supervisor will maintain a waiting list for such requests, and honor them on a 'date received' basis.
3. Day buoys shall be booked through the Beach Club Supervisor. A fee of **\$12.00 per 24 hour period** must be paid in full at the time you request a reservation. Day buoys may be rented for up to 7 consecutive days, with at least 5 days between rentals, and no more than 2 weekends in a 30 day period.
4. **Private renters may not rent a day buoy.**
